ANY ADDITIONAL OR DIFFERENT TERMS PROPOSED BY PURCHASER ARE OBJECTED TO BY AND WILL NOT BE BINDING UPON SELLER UNLESS SPECIFICALLY ASSENTED TO IN WRITING BY SELLER. AS USED IN THESE TERMS AND CONDITIONS OF SALE. "PRODUCTS" MEANS THOSE PRODUCTS SET FORTH IN THE ABOVE PAGES.

I. Acceptance. All orders received by SELLER are subject to final acceptance or confirmation by SELLER and no terms or orders are binding upon SELLER until so accepted.

II. Deliveries. Unless otherwise specified by SELLER in writing, all deliveries are EXWORKS SELLER'S warehouse in Blainville, Quebec (INCO Terms).
